**WHAT DO EDELMAN FINANCIAL SERVICES, LLC AND EF LEGACY SECURITIES, LLC DO WITH YOUR PERSONAL INFORMATION?**

**Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Assets and investment experience
- Account transactions and risk tolerance, and
- Employment information

When you are *no longer* our client, we continue to share your information as described in this notice.

**How?**

All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons Edelman Financial Services, LLC and EF Legacy Securities, LLC choose to share; and whether you can limit this sharing.

<b>Who is providing this notice?</b>	Edelman Financial Services, LLC, a registered investment adviser, and its broker-dealer affiliate, EF Legacy Securities, LLC.
What we do	
<b>How do Edelman Financial Services, LLC and EF Legacy Securities, LLC protect my personal information?</b>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings, as well as:</p> <ul style="list-style-type: none"> <li>▪ information access controls</li> <li>▪ service provider oversight and confidentiality agreements</li> <li>▪ proper disposal of client information</li> <li>▪ periodic security training for personnel</li> </ul>
<b>How do Edelman Financial Services, LLC and EF Legacy Securities, LLC collect my personal information?</b>	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>▪ open an account or seek advice about your investments</li> <li>▪ direct us to buy securities or direct us to sell your securities</li> <li>▪ enter into an investment advisory contract or tell us about your investment or retirement portfolio or earnings</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes — information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Our affiliates include the financial companies providing this notice, Edelman Financial Services, LLC and EF Legacy Securities, LLC.</i></li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Edelman Financial Services, LLC and EF Legacy Securities, LLC do not share with nonaffiliates so they can market to you.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ <i>Edelman Financial Services, LLC and EF Legacy Securities, LLC do not jointly market.</i></li> </ul>
